Specht (1993)² mentions that entrepreneurship is about the creation of a systematically planned, properly organized and highly managed product with drastically upgraded yield from resources and therefore create a new source of market with a new customer. For the development of entrepreneurial orientation Culture, education and environment have an internal locus of control. Bamzia, P. N. K (1973)³ writes that it has turned out to be a word wide movement which spreads across countries regardless of their level of development or even of their basic mentality or even value orientation towards the business activities.

The entrepreneurship development is viewed as the latent or the manifest consequence of East India Company's arrival in India as it gave a new stimulus to the Indian businessman by injecting various changes in the Indian economy and accelerates the export of raw

material and import finished goods. In the recent years, especially since 2004, the Jammu and Kashmir Entrepreneurship Development Institute has emerged as important institution for the development of entrepreneurial orientation in the state. The contribution to the employment development is also observed. The provision of certain packages to the educated unemployed youth of Jammu and Kashmir in the form of certain schemes sponsored by Center and State Governments have made the things easier for the state people and less risk prone. These schemes include the facilities of financial assistance, and training. The assistance under these schemes helped people to consider the entrepreneurship as a growing career choice and therefore witness a paradigm shift from sticking to Government jobs only and develop an entrepreneurial orientation among the people of the state. The characteristics of entrepreneurship are more of creativity, innovation, resource gathering and finding out of an economic organization that gives us a chance of gain under risk and uncertainty. It is a kind of sensitive activity which helps to generate and sustain the economic growth to develop an orientation of profit making and boost the employment too. Schumpeter (1942)⁷ mentions that an entrepreneur is an innovative agent of growth and change where resources are scarce and therefore new combinations with an existing set of resources contributes to the economic growth. Watson (1995)⁶ says that entrepreneurship development is one of the most significant and essential was of expanding the industrial development of

the society. It is an activity that initiates, promotes and maintains the production and distribution of wealth. McClelland (1961)⁸ views the role of entrepreneurs differently as that of an omnipotent creator. It an activity that cannot be inherited only but can be learnt too and the best way to learn is to practice it as it is more of practice an experiment then of art or any science. It is a new way to start and extend the social and political entrepreneurship activity as very rarely does an efficient state discuss the economic conditions without the reference of entrepreneurs and their importance in creating more prosperous future for the citizens of the state. Global Entrepreneurship Monitor has noted a wide range of variations in entrepreneurship activity throughout nations of the world while the average percentage of world's population involved in the entrepreneurship activity was near 9% for the period of 2001-2003, the range of activity in the 40 countries analyzed spanned from low a low of 2% to high of 29%. The Global Entrepreneurship Monitor suggests powerful role to the entrepreneurial orientation and the entrepreneurship development of a place. In addition to the role of Global Entrepreneurship monitor, the impact of culture and environmental factors are perceived to influence the entrepreneurial orientation of the people.

Entrepreneurship Development in Jammu and Kashmir: Jammu and Kashmir is found to be one of the best entrepreneurial destinations of world besides the problems of conflict and climate hamper the normal course of entrepreneurial action. The people of the state are innovative in nature with a workable and efficient ideology. A study by Mercy Corps under the Project of SKYE (Start Up Kashmiri Youth Entrepreneur) reveals that majority of the people in the state ant to be self-employed but the low entrepreneurial orientation makes them lag certain qualities of entrepreneurship and therefore suffer in the field of entrepreneurship. The study also reveals that people over their also feel deprived of the knowledge and the essential requirements of the business too. Barker A. F. (1933)⁴ finds that Jammu and Kashmir is the rich heritage of the handicrafts, tourism, wood carving and paper Mashi too, but still it has been observed that the state is least counted among the entrepreneurially sound states of the world. In order to deal with the declining rate of entrepreneurial orientation and entrepreneurship development, the emergence of Jammu and Kashmir Entrepreneurship Development Institute is proving as one of the good intervening agency in the problem. The state has given an important mandate to Jammu and Kashmir Entrepreneurship Development Institute to help, train and mentor aspiring and practicing entrepreneurs through counseling, awareness and consultancy and research. The institute started its regular activities from February 2004 and has been playing a very dynamic role in creating a pro entrepreneurial environment. It is established in the three regional centers at Jammu, Srinagar and Leh. However the main campus of the institute is in the district Srinagar of Jammu and Kashmir located at Pampore. The function of the institute is mostly the financial assistance under four schemes. The Seed Capital Fund Scheme, (SCFS) The Youth Start Up Loan Scheme (YSLS), Himayat and National Minori-Development Finance and Corporation (NMDFC). A subsidy amount is also provided under the scheme of Seed Capital Fund Scheme and Youth Start Up Loan Scheme. However under the Himayat and National Minorities Development Finance and Corporation, the interest rate is levied is low for the entrepreneurship development.
